Under the ACA, emphasis on the importance of integrated primary care and the social determinants of health have been the underlying paradigm in reform efforts, and NYS has worked vigorously to position health care and behavioral health providers to best collaborate on these efforts. Now, plans for the repeal and replacement of provisions in the ACA that affect spending and revenues — including the federal subsidies, Medicaid expansion, taxes and mandates that all individuals obtain coverage, and turning control of Medicaid over to the states (block grants) could lead to reductions in care. Hear national and state experts engage in an interactive dialogue on the impact national efforts may have on New York's health and behavioral health system, and more importantly, those we serve.

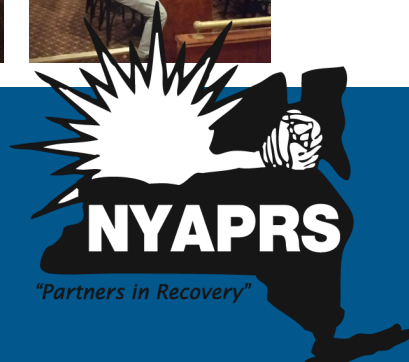

INDIVIDUAL MEMBERSHIPS are for individual practitioners, researchers, policy-makers and others who are directly involved in the delivery of psychiatric rehabilitation and self-help services, or in publicly funded community-based mental health services in general. *Individual members are eligible for one vote in all NYAPRS elections.*

ASSOCIATE INDIVIDUAL MEMBERSHIPS are for consumers, family members and students not working in the delivery or community-based mental health services. *Associate members are not voting members of NYAPRS.*
